

Petition for a Court Order of Protection - Adult

Due to the actions of the defendants, it is important that we bring this matter before the court as the harassment, slander, and defamation continues.

Your honor, before you get started please take a moment to read **(SEE EXHIBIT 1) - NOTICE TO CEASE AND DESIST - November 9, 2025**. Also, because of their actions Anita contacted the local police department. They did review Anita and Branson Outreach request, and threw it to the ground after reading it.

On October 22, 2025 there were many requests made for food deliveries from Branson Outreach (**A For Profit Business**) as the government shutdown made a lot of poor people uneasy about what the next meal would look like.

On this particular day, Anita was very busy placing orders for families, bagging groceries, and getting a team together to make the deliveries as the incoming calls were constant. **Things were quite busy this day.**

A call came through and Anita answered. This call was from a person wanting to help a family. They wanted to send **\$200.00 through “VENMO” a credit card company that Anita does not have.**

Because Anita has **bent over backward on many occasions to help Melissa and Jeremy**, including **giving them monies to go home last year**, Anita asked Melissa to accept the payment as they “DO” have a Venmo card, and they did accept the payment.

They brought the \$200.00 to Anita and she quickly handed it to me (Dallas L. Williams, Jr. - Husband) to hold as the phone calls seemed to never stop that day.

While Anita was on the phone, and **Jeremy and Melissa standing in our doorway**, Anita asked if they would make that delivery. **They stated yes.** This was a **frantic call** from a family in **“Rock Away Beach”** needing food. This shows Branson Outreach strength and ability to help others outside the Branson community.

Anita was **determined** to help that family as there was also another family in that area needing food.

*****THIS IS VERY IMPORTANT*****

Anita, being the type of person she is and knowing the distant Jeremy and Melissa would have to travel, **Anita gave them \$25.00** for gas, and because they had a little child and could not do any other work that day, **Anita gave them an “ADDITIONAL” \$100.00 so they can buy food for themselves and their daughter.**

“That money **came from the \$200.00 cash they handed to Anita**”.

SO, THEY SPENT \$125.00 OF THE MONEY THEY ARE “SLANDERING, HARASSING, AND DEFAMING” ANITA AND THE BRANSON OUTREACH WARRIORS ABOUT. THEY THEMSELVES WERE RIDING WITH THE MONEY IN THEIR POSSESSION.

When they returned after making deliveries and buying their groceries, I asked Jeremy can he take a look at my car and tell me where the leak is, as Anita and his wife suggested he a good mechanic. He told me what to buy, I **gave him \$20.00 to purchase the gasket**, and I gave him **\$100.00 to repair my car**. (SEE EXHIBIT 2). - Image of the gasket.

THEY RECEIVE AN ADDITIONAL \$125.00 OF MY “PERSONAL” MONEY TO REPAIR MY CAR. (THEY SCAMMED ME).

On this particular day these **2 individuals received a total of - (\$245.00)**. -

CAN YOU IMAGINE HOW MANY OTHER NEEDY FAMILIES ANITA COULD HAD SPLIT THAT MONEY WITH. BUT YET, THESE SCAMMERS ARE CALLING ANITA AND THE BRANSON OUTREACH WARRIORS SCAMMERS.

They spent “\$125.00” of the money they are claiming Anita has committed a fraud with, and then they received an additional \$120.00 from me.

The problem that I see is that **these individual collected the money through their Venmo and “KNEW” the tagline suggested Anita give that \$200.00 to a particular person**. (SEE EXHIBIT 3) - Facebook Message (Tena)

They did not share that information with Anita until they suggested Anita stole some money ONLINE IN A FACEBOOK GROUP. - “AND THEY HAVE THE PROOF”

Anita website has a policy statement located here (<https://bransonoutreach.org/policy.html>) - that clearly states in the

“MEDIA” section that no one have the rights to “screenshot” information without approval from the owner. Yet, they are doing so without permission.

These individuals spent \$125.00 of that money because that was the “ONLY” cash Anita had on hand at that time and she was not made aware by Jeremy or Melissa what the tagline stated.

“The \$200.00 should had gone to Tena and “THEY” knew it.

In closing I want the court to know that these individuals have been collecting **food stamps, and SSI check, from Ohio** and working **“UNDER THE TABLE”** in Branson, MO. I believe them to be scammers **as their (EARNED) income is not being reported to the food stamp office.**

I believe they have **“SCAMMED” Ohio food stamp division and certainly they have scammed, slandered, harassed and defamed Anita and the Branson Outreach Warriors.**

Due to their statements, **we are asking the court to have these individuals produce and provide to the courts and Anita G. Williams the information that they “CLAIM” they have in their possession. As Anita know the money went straight to their pockets. Anita felt the child should eat well too.**

Wherefore, petitioner hope and pray that the court render a favorable decision and stop them from making false and defamatory statements as these statements has caused harm to Anita’s business practice as she is having to focus on answering to foolishness, when real people are needing real help.

Anita is asking that respondents pay all court cost/fees. Any monetary decisions shall be left to the court, as Anita feels they would not be able to produce payment. Therefore, \$1 for their actions, and a sincere apology letter will do.
